

By-Law Changes

In accordance with the current by-laws, proposed changes to the by-laws were printed in the Aerostats. There have been no formal comments sent to the WAS Executive Board. If you have any comments, please forward them to Tim Gale and Koh Murai and Leslie Berning. A vote on the proposed changes will take place at the March 2013 meeting. WAS members may also vote via absentee ballot if not attending the March meeting.

There had been some concern about Officer Liability. This could be side-stepped with the proposed changes to the by-laws.

Treasurer's Report

\$1,409.65 [balance at Dec '12 meeting] \$1,624.65 [increased by member dues paid]

What to do with excess balance in the WAS account?

Leslie will compile a list of WAS yearly obligations and average expenses and report at the next meeting. This will give us an idea of how much we can spend. Of course, WAS will retain a reserve amount for emergencies. Several suggestions were discussed:

- Window clings -- would make our cars known to each other at events. Embroidered Patches -- Mark will look at a couple of companies and report back to the E-board with pricing options. Koh showed a sample of an iron-on embroidered patch.
- T-shirts -- unless pre-ordered, it could be difficult to get the right number in the right sizes. Silkscreen was much preferred to the rubber-ish transfer.
- Trading cards with WAS info on one side, and member's balloon photo on the other. But this option would be mostly for pilots, and not crew who crew for different pilots. Koh also showed examples of trading cards.
- Sponsor a student to a Balloon Camp.
- Sponsor more social events. Provide drinks or snacks to members at rallies.

Presentation on Radio Frequencies -- by **Randy Fuerher**

Randy's power point presentation was helpful and informative. Please go to the FCC website for more information. As of Jan 1, 2013 a Federal mandate goes into effect to use narrow bands on Business Bands. BB radio use requires a license.

The BFA has received tentative FCC approval for the frequencies listed here. Upon completion of due process, the FCC will issue the license to the BFA, and a copy will be available to download to carry in case proof is required. Please note that crew using these frequencies must also be a BFA member.

151.625, 158.400, 151.505, 451.800, 456.800, 456.8125

General Mobile Radio Service [GMRS] requires a license to use. Mark has his and offered to help other WAS members obtain theirs. FMR cannot be used above 20 feet from ground. Aircraft radios can be included in WINGS training.

Good of the Order


- Loose Goose in McMinnville is the same weekend as Rock of Ages, Aug

As an AGI, Mark may also endorse a student to take the written knowledge test for these pilot certificates (not just LTA candidate). He can also give the ground training for any flight review as well.
- Mark plans on offering ground school in the near future, as well as "refresher" courses during balloon rallies that he attends. These two hour refresher courses will be offered free to WAS members, and \$5 for non-WAS members.
- Tim suggested a radio etiquette course.

Wooden Shoe Tulip Festival


